
26 **BLOOMBERG LLC'S RESPONSE TO PSYCHIATRIC RIGHTS, INC'S**  
27 **REQUEST TO UNSEAL DOCUMENTS**

28 Bloomberg, LLC has no objection to the request made by Law Project for  
29 Psychiatric Rights, Inc. ("PsychRights") on August 20, 2008 to unseal any remaining  
30 documents that remain under seal in this matter. Bloomberg is committed to  
31 transparency in court proceedings, and this is certainly a matter in which the public  
32 interest is paramount. Eli Lilly has repeatedly failed to make the requisite showing to

1 keep documents under seal in this case. The Alaska Supreme Court has refused to stay  
2 this court's order of June 13, 2008 unsealing the great majority of documents that were  
3 sealed in this matter, and those documents have since been posted by PsychRights on the  
4 Internet. See <http://psychrights.org/index.htm>. Consequently, Bloomberg agrees with  
5 PsychRights that any remaining documents under seal should now be made available to  
6 the public.


